CODE OF CONDUCT/ STATEMENT OF FAITH/ AGREEMENT

AS CHRISTIANS WHO SERVE IN THE ART OF DANCE, WE ARE EXAMINED AND OBSERVED MORE CRITICALLY. AS DANCE IS STILL “CONTROVERSIAL” FOR MANY CHURCHES AND CHRISTIANS DUE TO ABUSES IN THE ARTS COMMUNITY. OUR WITNESS IS EXTREMELY IMPORTANT TO BOTH THE BODY OF CHRIST AND THE WORLD OF THE ARTS, BECAUSE THE LORD HAS CALLED US TO USE OUR BODIES AS LIVING SACRIFICE HOLY AND ACCEPTABLE AS A PROCLAMATION IN HONOR TO HIM. THEREFORE, WE MUST SEEK GOD’S GRACE AND GUARD OUR OWN HEARTS AS WE WRESTLE WITH THE SINS THAT CAN SO EASILY BESET US.

WORSHIPER BELIEVES AND PROFESSES TO THE BASIC TENETS OF THE CHRISTIAN FAITH; JESUS CHRIST, GOD COMES IN THE FLESH, BORN OF A VIRGIN, WHO SUFFERED, DIED, WAS BURIED, AND ROSE AGAIN IN ACCORDANCE TO THE HOLY SCRIPTURES. WORSHIPER AGREES TO ATTEND WEEKLY REHEARSALS ON WEDNESDAY 5:45-6:45; MONTHLY WORSHIP TIMES FROM 7-TIL FINISHED(9or10PM); EXTRA REHEARSALS ESTABLISHED AS NEEDED FOR UPCOMING SPECIALS; SUNDAY MORNING SERVICE STARTING AS EARLY AS 8:00 AM; ALL OF WHICH BEING PROMPTLY ON TIME. DO NOT SCHEDULE ANYTHING ON THESE DAYS. YOU ARE EXPECTED TO BE AT ALL SCHEDULED TIMES LISTED ABOVE UNLESS SICKNESS, EMERGENCY,OR PROPER NOTIFICATION. PROPER ATTENDANCE IS VITAL AND IMPORTANT IN BRINGING UNITY TO THE TEAM. TOO MANY ABSENCES MAY RESULT IN DISMISSAL OF THE TEAM.

WORSHIPERS ARE REQUIRED TO MAKE A COMMITMENT FOR UPCOMING SPECIALS OUTSIDE OF WEEKLY WORSHIP TIMES WITHIN A CERTAIN TIME PERIOD THAT WILL BE VERBALLY COMMUNICATED FOR EACH SPECIAL AS THE OPPORTUNITY PRESENTS ITSELF. ONCE YOU COMMITT, YOU ARE IN, NO EXCEPTIONS.
